# **Introduction:** Treat in Taunton Manor Rolls vs. Goodrich in Felsham Manor Rolls ~ By Steve Goodrich, Ph.D.

As mentioned in the June, 2016 issue of the Quarterly,<sup>1</sup> the Felsham Manor rolls 1378-1452 have been searched recently in an attempt to find further information about the Felsham Goodrich ancestry published by Ernest Flagg in 1926 (Figure 1).

GOODRICH. William Goodrich<sup>1</sup> of Wethersfield was son of John Goodrich<sup>2</sup>, of Bury St. Edmunds, co. Suffolk, Clothier, whose will is dated April 14, 1632. In it he mentions two sons named William the elder and William<sup>2</sup> the younger. His wife's name was Margery<sup>2</sup>. His father was

The Goodrich entries seen in the Felsham Manor rolls provide less detailed information than the Felsham wills dated 1475-1597; especially the later Felsham wills dated 1554-1597 cited by Flagg, which coincide with the proven portion of the Felsham Goodrich ancestry.<sup>3</sup>

In these later wills, in particular, the testator named one of his sons as the principal heir who acquired the family property in Felsham, as shown correctly by Flagg for generations (5 to 4)<sup>4</sup> and (4 to 3)<sup>5</sup> in Figure 1. Conversely; in the will of testator John Goodrich in 1475, he stated only that he preferred that one of his children acquire his property,<sup>6</sup> and in the will of testator John Goodrich in 1503, he stated his preference that son John acquire his property before any other.<sup>7</sup> Extending the Felsham Goodrich ancestry to William Goodrich of Hessett would require that his marriage to Margaret Richardson at St. Peter parish in Felsham on 07 November 1568<sup>8</sup> be considered in placing William Goodrich-Hessett as a son rather than a grandson (Figure 1) of Robert Goodrich-Felsham.

As described in the fourth article in this issue, two of the Felsham Goodrich wills: John Goodrich, Chaplain of Felsham (20 May 1423; proved 09 Jun 1424) and Rose Goodrich, widow of Felsham (02 Aug 1470; proved 27 Nov 1470), are believed to be named in the Felsham Manor rolls in 1412-1449. John Goodrich, Chaplain is also likely the Sir John Goodrich, Priest mentioned in the 18 Mar 1467 will of Felsham neighbor Baldwin Cocksedge, who is yet another plausible ancestor.

For orientation and comparative purposes, a presentation of the proven vs. plausible ancestry of the immigrant Richard Treat (1584-1669), ancestor of many descendants of Ensign William Goodrich (1622-1676), published by the late historian Robin Bush in 1999<sup>10</sup> is presented in the third article. In the case of the Treat ancestry, though the records offer more detail for genealogical connections, there is the challenge of more coexisting families in the larger, multi-village Taunton Manor.

#### **Basic Feudal Land Tenure Terms**

**LAND** (old acres; 4 old = 1 modern): hide/carucate (120), virgate (30), ferling (7.5), dayne (?), curtilage (house yard).

MESSUAGE: dwelling house with outbuildings and associated land.

**HERIOT:** death duty a tenant paid to the lord of a manor; often in currency of valuable livestock.

**<u>BONDLAND:</u>** manor land which commonly had ancient dwelling tenements and was held by a customary fine and rent with the payment of heriots and performance of other customary services.<sup>11</sup>

**OVERLAND:** manor land that typically had no dwelling places, and though held by a customary fine and rent, tenants paid no heriots or performed other customary services. <sup>11</sup>

**<u>DEMISE:</u>** to convey a property or estate by will or by lease.

**COPYHOLD:** a form of landholding involving the tenancy by non-freemen of tracts of land, including bondland and overland, belonging to the manor of the feudal lord<sup>12</sup> in accordance with the customs of the manor, which could vary in different manors.<sup>13</sup> The copyhold tenant could not sell, bequeath or otherwise convey his property by deed, but rather could surrender the land in the customary court of the lord of the manor into the possession of the lord for the use of the person who was to acquire the property. The only evidence the copyhold tenant had regarding the property was the copy of the transaction of the customary court.<sup>14</sup> The requirement that property transfer take place through the manor court benefits genealogical research when manor rolls are available, yet it may have precluded drafting of wills.

**FREEHOLD:** ownership of an estate held and sold or bequeathed at will by the customs of the manor, yet not under the control of a lord, by persons who possessed the rights of a free man under the Magna Carta. <sup>15</sup> In this case, transfer of property could take place outside of the manor court and so not be found in surviving manor rolls, yet the ability to bequeath property directly favored drafting of wills which revealed all surviving family members of the testator. Freeman status in the American colonies was superseded by the Declaration of Independence and the Bill of Rights.

**KNIGHT SERVICE:** military duties performed in return for payment, typically in the form of land. Military services could include: deployment in wars or military expeditions, riding and bodyguard services, guarding the castle, and others. To obtain knight service, a lord could enfeoff (*grant a fief to*) one knight directly, or to a man who procured multiple knights. <sup>16</sup>

**KNIGHT'S FEE:** the land allocation considered necessary to support a knight and all his required resources. The knight's fee could vary widely depending on the nobility-military status of the recipient and the relative quality of land being allocated, making the determination of an average knight's fee a long-sought yet difficult task, yet in one known published instance of available data the knight's fee of nearly 500 11<sup>th</sup>-century knights from the Domesday Book was about 1.5 hides (180 acres).<sup>17</sup> Price inflation later caused the knight's fee to increase, the number of knights to drop, and more knight service performed by persons of increasingly rural vs. professional military experience.<sup>18</sup>

**SCUTAGE:** a means by which a knight could commute the military service that he owed his lord by making some form of payment, though tenants could not refuse required military service. <sup>19</sup>

**SOCAGE:** a form of land tenure in which the tenant lived on his lord's land and in return rendered to the lord a certain agricultural service or monetary rent.<sup>20</sup>

**AMERC:** penalty by monetary fine.

**SEISE:** legal possession.

**ALIENATE:** a legal transfer.

**FEALTY:** loyalty; particularly to the lord of the manor.

**<u>DISTRAINT:</u>** the seizure and holding of goods or property in order to obtain satisfaction of a claim.

### Proven vs. Plausible Treat Ancestry in the Taunton Manor Rolls

The ancestry of immigrant Richard<sup>1</sup> Treat (1584-1669), as published by John Harvey Treat in 1893, was: **Richard<sup>1</sup> Treat** (*Robert, Richard, William, John*), after a search he described as follows:<sup>21</sup>

I have compiled a pedigree of the family in England, for six generations, as best I could from the scanty probate, manor and parish records. There are doubtless some errors. I can trace the family back without any difficulty for four generations to Richard Trott. Beyond that point there is a difficulty. There are no parish registers before 1538, and no wills at all relating to our branch of the family. The Taunton Manor Rolls are our only sources of information. There is a calendar, not complete however, quite well preserved, from 1450–1666, but in the present condition of the records it is utterly useless. It would require months of search and great expense to find the documents indexed. As this was a matter of no great importance, I did not feel like undertaking the work. Have thought best to give all the names of Trott found in the calendars between 1450 and 1573, in order to show our authority, in the absence of direct proof, for regarding John and William Trott as the founders of our family, they being the only Trotts in Taunton Manor, and their names having been common ones in the family. The names are in Latin:—John, William, Richard and Robert.

The first record of Trott in Taunton Manor in County Somerset is in Obridge, Staplegrove Hundred as early as ~1250 AD, and remained there until proven grandfather Richard Trotte, possible son of John Trotte, acquired properties in Otterford and South Trendle (later Trull) in 1526-1533. The ancestral line of Richard<sup>1</sup> Treat belonged to Pitminster parish and resided in Trull<sup>22</sup> in the map. <sup>23</sup>



The transfer of the Taunton Manor records from Taunton Castle to the Somerset Record Office from 1936-1940 facilitated the later rigorous study of the Taunton Manor records 1423-1640, indexed in the manor calendar (*surviving records go back as far as 1207 AD*), by the late historian Robin Bush, who published his findings in 1999.<sup>24</sup> William Trotte, an ancestor postulated in 1893, was found to have had only two daughters and so he was not an ancestor, and a calendar entry interpreted as Richard Trotte in Staplegrove in 1509 was found to be Richard Torre.<sup>25</sup>

A Treat surname variant is first recorded in a Taunton Manor custumal in about 1250 AD, when Richard Trot was a tenant of 5 acres paying rent of 2 shillings per year in Taunton St. James parish in Staplegrove hundred, where he was required: "to come to four harvest boomworks, to mow and make hay, to come to the rickmaking and the waterlete and to the corn rick in autumn and to hoe," in performing customary works for the lord specified by the custumal.<sup>26</sup>

In the following Trotte/Treat entries for Taunton Manor, only records involving plausible or proven Treat ancestors are shown in full in bold font; the others in italics include only year, location, name and any readily-discernible genealogical information of potential interest in order to demonstrate number, frequency and locations of Trotte/Treat families and entries found by Robin Bush.<sup>27</sup>

### **Constructing the Ancestry of Richard<sup>1</sup> Treat**

From the manor rolls and parish records shown, Robin Bush attempted to construct the Treat ancestry, paraphrased below with annotations, for the ancestry of immigrant Richard<sup>1</sup> Treat only:<sup>30</sup>

Richard Trot; held five acres in the Obridge tithing of Staplegrove Hundred in the parish of Taunton St. James in about 1250 AD. From him were possibly descended:

- a. William Trotte, a tenant in Staplegrove Hundred 1432-3
- b. John Trotte, possibly brother of William (see 1)
- 1. John Trotte (b. above); Staplegrove Hundred in 1435-6; probably died 1439/40 to 1447/8
- 2. John Trotte Jr. of Staplegrove Hundred 1439-40; Grasscroft, Pyrland tithings 1447-1455
- 3. John Trotte of Staplegrove tithing in 1469-1476; his probable children were:
  - a. William Trotte; succeeded John Trotte in Holford of Staplegrove 1502-1504; died 1541-2
  - b. Richard Trotte; possible younger son; left Staplegrove for Otterford, Trull 1526-1534
- 4. Richard Trotte (also 3-b); earliest proven ancestor; m. Joan; d. ~1570; had sons:
  - a. John the Elder (likely namesake was 3. John Trotte; buried at Pitminster 16 Oct 1544)
  - b. John the Younger who inherited his Otterford property
  - c. Robert who inherited his Trull property
- 5. Robert Trotte (also 4-c); proven ancestor; m. Honour; buried 15 Feb 1599/00; had sons:
  - a. John, surgeon of Pitminster; m. Edith Priest; will dated 11 Apr 1633
  - b. Richard, the immigrant of Wethersfield, Connecticut probably soon after 29 Jun 1637
- 6. Richard Trotte/Treat (also 5-b); bp. 1584; of Trull 1599/00; m. Alice Gaylord; d. 1669-CT.

In a similar manner, the Gaylard/Gaylord ancestry of Alice Gaylord, the wife of the immigrant Richard<sup>1</sup> Treat, was determined from the Taunton Manor rolls<sup>31</sup> (with approximate lifetimes; the ancestry of Johanna Sevenock was traced to John Sevenock: 15 acres in Poundisford 1423-24):<sup>32</sup>

Nicholas Gaylord (1525-1572); m. Johanna Sevenock who m2 Giles Alvin Hugh Gaylord (1553-1614); m. Alice \_\_\_\_\_\_ Alice Gaylord (1594-1669); m. Richard<sup>1</sup> Treat

The Taunton Manor rolls appear to have recorded the transfers of copyhold property between successive generations of the Treat ancestry. Though there are no instances in which a direct father-son bequeath is noted in the records, as would be expected, in numerous instances the arrangement for the son to acquire the property on the part of the father is noted in specific detail.

One noteworthy exception is Richard Trott, who acquired properties in the Poundisford Hundred tithings of Otterford (1526-7) and Trull (1533-4) with no indication that the properties were owned previously by his father or other Treat relative, and furthermore none of his subsequent property acquisitions made mention of a grant by his father.

This is why the grandfather Richard Trott is considered to be the earliest proven ancestor in the ancestry of the immigrant Richard<sup>1</sup> Treat. However, what appears to be the eldest son of the grandfather Richard Trott was named John and died young, and so may have been named after his paternal grandfather John Trott of Staplegrove, whose apparent eldest son and heir of the properties in Staplegrove Hundred was William Trott, whose sole heirs were his daughters Johanna and Lucia.

Given the large number of Treat families and the frequent duplication of first names in different families, it would be very difficult if not impossible to assemble the ancestry of Richard<sup>1</sup> Treat without the customary transactional details in the Taunton Manor records, including notation of how the person who acquired a property was granted the rights to the property, which frequently reveals father-son relationships since a father is usually recorded as a father in the records.

The principal reason for discussing transactions of the Treat ancestry in the Taunton Manor rolls is to provide a reference for comparison and contrast with the records of Goodrich in Felsham Manor in the next article, which are very different in transactional detail. In fact; there is not a single purchase or sale of land by Goodrich in the available Felsham Manor rolls from 1378-1453.

It is for this reason that the rationale for inclusion of the full transcribed wills of John Goodrich, Chaplain of Felsham (1423) and Rose Goodrich, widow of Felsham (1470) in the June 2016 issue will become apparent in the presentation of the Felsham Manor rolls 1378-1453 in the next article.

#### Proven vs. Plausible Goodrich Ancestry in the Felsham Manor Rolls and Wills

Since the Felsham Goodrich wills 1475-1563 were first described in the December 2009 issue of the quarterly,<sup>33</sup> a means to find the 4-5 missing generations between John Goodrich of Felsham, whose will was dated 30 Nov 1475 and proved 17 Dec 1475,<sup>34</sup> and Robert Goodrich of Felsham, who paid a subsidy of 5s in the 1327 Felsham subsidy,<sup>35</sup> has been sought, though as was seen and understood by Flagg as early as 1926, only the wills from 1554-1563 involved proven ancestors.<sup>36</sup>

It is noteworthy that a will record exists for the Felsham Goodrich ancestry, given the expectation that freehold ownership of property would be required to allow for the property to be bequeathed directly by a will without the intermediacy of the manor court of the lord. And if the property of potential Felsham Goodrich ancestors prior to 1475 was freehold, it would be possible that records of their land transactions would not be found in the 1378-1412; 1437-1452 Felsham Manor rolls available in the Bury St. Edmunds Branch of the Suffolk Record Office.<sup>37</sup>

On Friday, June 10, 2016 the Felsham Manor rolls 1378-1412; 1437-1452 were searched for any Goodrich entries by Diana Spelman and her husband Tom, <sup>38</sup> who were able to search all of the manor rolls in a single visit. In the next paragraph, her discussion of their findings is presented first, followed by her verbatim presentation of the manor roll records. All speculations regarding the construction of a plausible Felsham Goodrich ancestry were produced by the author and Joseph Neilson, whose extensive compilation of Goodrich records in England from earliest times (accumulated during his search for the ancestry of immigrant Thomas Goodrich of Old Rappahannock, VA prior to the confirmation by Y67 and Y111 Y-DNA tests in 2008 and 2011 and the L1019 Y-SNP test in 2012 of a Felsham Goodrich connection)<sup>39</sup> was consulted for most of the records presented in the article in the December 2009 issue of the quarterly.<sup>33</sup>

The very earliest roll, 1700/1/2, covers the years from 1378 to 1396 (with gaps). Tom examined this roll and says some MEMBRANEs are in poor condition, with the handwriting very faint, but he managed to read most entries. Unfortunately, most of this roll records proceedings in the manor courts held for Thorpe Morieux and he found no entries for Goodrich or variants there. There are just two Felsham manor courts recorded here, one held in December 1382 and the other in August 1383, but the earlier court does include an entry relating to **John Godrych and Isabel his wife**, as the executors of Margaret or Margery (the Latin is abbreviated as *Margar'*, so could be short for either name) Baldeman. (They were involved in a court case, a plea of debt, with one John Atte Dych).

The second roll, which I examined, covers the years from 1402 to 1412 and records a more even mixture of courts held in both Felsham and Thorpe Morieux. Here I found mention of John Goodrych/Goodrich senior in 1403 and 1408, and John Goodrych junior in 1412. The second court of 1412 records a particularly interesting entry, for this records that John Godrych chaplain was the son and heir of John Godrych deceased. There is also mention of John the chaplain's brother Geoffrey, also a chaplain.

The third roll, which I also examined, covers the slightly later period of 1437-1453 and records courts held for Felsham & Drinkston, as well as Thorpe Morieux. There is mention of John Goderych/Goderich(e) in 1439, 1440 & 1442, presumably the same John mentioned in 1451 and 1453. You will notice mention of a Richard Goderich in 1440, but I rather suspect this is a scribal error, for he appears recorded as John in the very next court regarding the same

matter. Finally, we have one Rose Goodrych mentioned in 1449. (In passing, as you will see, I have noted mention of Baldwin Cocksedge on this roll, in case you can see anything of interest.)

(Concerning) the survival of Felsham manor court records...Some records were deliberately destroyed down the years (e.g. manor court rolls were targeted in the 1381 Peasants Revolt), while others were accidentally destroyed (e.g. in the bombing during World War II). Some records were preserved well, in dry, secure archives, either in public or private hands, while others were subject to damp or were eaten by mice etc. Some documents were kept, because they were seen as important to their owners, while others were simply thrown away as being old and of no relevance...It is impossible to say how or when the rest of the Felsham manor court records disappeared. Many manors have good series of rolls and court books, but these are usually of much later date; it's uncommon to find continuous series running before 1500 or 1600. Sometimes, nothing at all appears to survive until the 18<sup>th</sup> century or later. The emphasis here should be on 'appears to survive' - there is still material out there, in private hands, which is not on the radar of Record Offices, so one never knows what might come up for sale in the future!

#### **Discussion**

All potential Goodrich ancestral generations in the Felsham Manor rolls precede the earliest proven Goodrich ancestor, John Goodrich of Felsham, whose will was dated 20 May 1554 and was proven 08 Oct 1558 and bequeathed his property to his son Robert Goodrich of Felsham, 40 whose will dated 26 Jun 1563 and proved 22 Feb 1569/70 named principal heir Adam Goodrich of Felsham and third son William Goodrich of Hessett, 41 who in turn are the known paternal grandfathers of immigrant Thomas Goodrich (1615-1679) of Old Rappahannock, VA, and immigrant brothers John Goodrich (1618-1680) and William Goodrich (1622-1676) of Wethersfield, CT. It is likely that unproven Goodrich ancestors represented by Felsham wills of John Goodrich (30 Nov 1475; proved 17 Dec 1475)<sup>34</sup> and John Goodrich (20 Aug 1503; proved 11 Sep 1503),<sup>42</sup> will remain unproven indefinitely, and so by necessity any attempt to postulate an ancestry from the available Felsham Manor rolls can produce only plausible ancestors.

The Felsham Manor rolls Goodrich entries from 1382-1453, as described below:

- 1382, 1403 and 1408 entries mention John Goodrich Sr., whose wife Isabel appears in 1382.
- Oct 1412 entry, Membrane 10, mentions John Goodrich, Chaplain son of late John Goodrich Sr.
  - o Likely John Goodrich, Chaplain of Felsham; will 20 May 1423; proved 09 Jun 1424. 43 ■ The will of John Goodrich, Chaplain-Felsham bequeathed to John Goodrich the Younger. 43
    - The will of John Goodrich, Chaplain-Felsham named Geoffrey Goodrich as executor.
      - Geoffrey Goodrich, Chaplain-Lavenham will 06 Jul 1423; proved 23 May 1424.<sup>44</sup>
  - o Also likely Sir John Goodrich, Priest cited in the 18 Mar 1467 will of Baldwin Cocksedge. 45
    - Baldwin Cocksedge cites a croft of 4 acres he purchased of Sir John Goodrich, Priest.

    - Baldwin Cocksedge names daughter Margery; possibly wife of John Goodrich (will 1475).
  - o Entry states that the death of John Goodrich Sr. was recent.
- Mar 1412 entry in Membrane 9 mentions John Goodrich, Jr.
  - o Likely John Goodrich the Younger in the 1423 will of John Goodrich, Chaplain-Felsham.
  - o John Goodrich in 1439, 1440, 1442 entries is also probably John Goodrich Jr./the Younger.
- Rose Goodrich (Jan 1449) is probably Rose Goodrich, Widow of Felsham (will 02 Aug 1470).
- John Goodrich (1439, 1440, 1442, 1451, 1453 entries) is probably John Goodrich (will 1475).



Though it is understood that any proposed ancestors prior to John Goodrich of Felsham, whose will was dated 20 May 1554, are likely to remain only plausible and possibly never proven, an attempt was made to connect Robert Goodrich of Felsham who appeared in the 1327 subsidy and, most likely as a widower, appeared with son John Goodrich and daughter-in-law Margaret in the 1336 Felsham Feet of Fines<sup>47</sup> with the Felsham Goodrich ancestors whose wills were dated 1475-1563.

The result, which includes postulated dates of birth for the children named in the 1475-1554 wills based on the order they are named in the wills, is shown in the table below. Fortunately, violations of the custom of the manor, regardless of tenure status of the tenant, were recorded with useful genealogical information, such as John Goodrich Sr. vs. Jr. and John Goodich, Chaplain son of John Sr. Otherwise the Felsham Manor rolls could have had no Goodrich entries at all.

As was the case with the wills dated 1475-1554, what appears to be a single Goodrich ancestral heir per generation in Felsham (with a possible exception of John Goodrich, Jr. and John Goodrich, Chaplain stated in 1412 that ended in 1424) enhances the plausibility of the ancestry below.
